Release and Waiver of Liability, Assumption of Risk Indemnity Agreement

RE: 2012 CAPL Ski Trip, March 16th 2012 (the “Event”) Lake Louise (the “Location”) Alberta

IN CONSIDERATION if being permitted to complete, officiate, observe, work for, or participate in any way in the Event;

THE UNDERSIGNED, (the “Participant”) for himself, his personal representatives, heirs, and next of kin by his execution hereof **HEREBY**:

1. Acknowledges, agrees, and represents that he has or will immediately upon entering the Location, and will continuously thereafter, inspect the Location, and further agrees and warrants that, if at any time he is in or about the Location and he feels anything to be unsafe, he will immediately advise the officials of such and if necessary will leave the Location and/or refuse to participate further in the Event.
2. Releases, waives, discharges and covenants not to sue the Event committee; the Event participants; the CAPL; the Location owners, operators, and officials; the underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or Event; and each of them, their directors, officers, agents and employees, (collectively for the purpose herein referred to as the “Releasees”) from all liability to the Participant, his personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the Participant arising out of or related to the Event, whether caused by the negligence of the Releasees, or otherwise.
3. Agrees to indemnify and save and hold harmless the Releasees and each of them from any loss, liability, damage, or cost they may incur arising out of or related to the Event whether caused by the negligence of the Releasees, or otherwise.
4. Assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to the Event whether caused by the negligence of Releasees, or otherwise.
5. Acknowledges that the activities of the Event are very dangerous and involve the risk of serious injury and/or death and/or property damage. The Participant, also expressly acknowledges that injuries received may be compounded or increased by negligent rescue operations or procedures of the Releasees.
6. Agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasees, including negligent rescue operations and is intended to be as broad and inclusive as is permitted by the laws of the Province in which the Event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
7. I have read this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and voluntarily without any inducement, assurance or guarantee being made to me and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
